- 1. Final NAESPA Comment Letter on ED's Draft Updated Title I Equitable Services Non Regulatory Guidance (Jonas Zuckerman) <u>NAESPA Comment Letter</u>
 - Jonas shared Wisconsin's Equitable Services feedback on the Government Relations Committee <u>message board</u>. Other states were encouraged to do the same.
 - Julia Martin drafted the letter with committee members providing comments. The letter was sent on March 25.
 - Limited response is expected regarding comments. The final version of the guidance is not expected for at least another 3 to 4 months. Though the guidance applies now, it could possibly be amended in future. States could start adjusting policy around draft guidance.
- 2. Consider a NAESPA Comment Letter on ED's DRAFT State and Local Report Cards Guidance (Jonas Zuckerman)

The U.S. Department of Education (Department) released a draft document, titled <u>Opportunities and Responsibilities for State and Local Report</u> <u>Cards under the Elementary and Secondary Act of 1965, as Amended by the Every</u> <u>Student Succeeds Act</u>, for stakeholder review and comment. This document, which is attached and posted at <u>https://www2.ed.gov/policy/elsec/leg/essa/index.html</u>, clarifies for states and school districts the reporting requirements in section 1111(h) of the Elementary and Secondary Education Act of 1965, as amended by the Every Student Succeeds Act, and provides information states and districts may consider in developing and disseminating report cards. This document builds on information provided in fall 2018 in <u>A Parent Guide to State and Local Report Cards</u>.

This document is posted for review and comment through April 29, 2019. Please refrain from providing line-edits. Instead, submit substantive comments about the content to <u>OESE.Feedback@ed.gov</u>with the subject "State and Local Report Cards" by April 29.

In addition to your feedback on the content, please also identify any topics that you think are missing. The Department will consider all comments in making revisions but will not provide responses to individual comments.
