

FY 2022 Award

- FY 2022 appropriation for MEP: \$375.6 million
- Awarded July 1, 2022

• Funding will not be available for FY 2021 supplemental awards.

Consortium Incentive Grant (CIG) Continuation Awards

• FY 2022 CIG continuation awards are expected to be issued in August 2022.



OFFICE OF SCHOOL SUPPORT AND ACCOUNTABLITY (SSA)



Recent activities:

- To support States and LEAs in planning for school year 2022-2023, ED issued preliminary allocations in March 2022
- ED issued final allocations in June, which differed from the preliminary allocations for all SSA programs (except for Title III, Part A and Title IV, Part B) due to availability of updated data for certain formula elements
- The grant awards that States received on July 1 are based on the final allocations



A look ahead:

- The FY 2022 appropriation act made a portion of FY 2022 Title I, Part A and Title II, Part A funds available for ED to award in July and makes the remainder available in October 2022
- If there are any changes to the FY 2022 Title I, Part A or Title II, Part A allocations before October, ED will reflect the changes in the October awards
- ED has awarded all FY 2022 funds from the FY 2022 appropriation act for the other SSA formula programs



A look ahead:

- For Title I (Parts A and D), this fall ED will send States neglected and delinquent child count survey materials
- Survey will collect October 2022 counts of children in locally operated facilities for neglected or delinquent children (for Title I, Parts A and D, Subpart 2) and calendar year 2022 counts of children in State-operated facilities for neglected or delinquent children (for Title I, Part D, Subpart 1)




- To calculate FY 2023 Title I, Part A allocations ED will use ages 5 to 17 LEA poverty and population estimates from the U.S. Census Bureau (Census) for calendar year 2021, which Census plans to release in late 2022
- As in prior years, ED will notify States when Census releases the 2021 estimates and the dates of the challenge period that Census provides
- The 2020 decennial Census will affect calendar year 2021 Census poverty estimates released in late 2022 for use in FY 2023 allocations

- **Title II, Part A**: Since FY 2017, ED has annually reduced the NCLB hold harmless amount in calculating State program allocations, per ESEA requirements. The FY 2023 allocations will be the first for which the hold harmless will be eliminated.
- Title III: In FY 2021 and FY 2022, as a response to COVID assessment issues, ED used State-reported ELP assessment count data from SY 2018-2019 in making State allocation calculations. In FY 2023, ED will return to using the most up-to-date ELP assessment count data available (data from SY 2021-2022).

Allocation Notification Process



Preliminary allocation notifications:

- Provides States and LEAs with estimates to support planning for the coming school year and information about the allocation calculations
- SSA sends to States once there is an appropriation that sets funding levels for programs and SSA has data necessary to calculate estimates (e.g., for Title I-A, new Census LEA poverty estimates)
- Preliminary allocations may differ from the figures available from: <u>State Tables on ED Website</u>



State Tables on ED Website note:

Updating the State tables — The State tables are posted and updated as a package, rather than on an individual basis. As a result, changes are not necessarily made to every program and/or every State each time the tables are updated. Major updates normally are posted for significant milestones in the appropriations process, such as the President's Budget Request and enactment of an appropriation. Major changes also are made when final allocations occur for the Elementary and Secondary Education Act programs usually in July. In addition, routine updates are performed each month, as needed, and typically reflect only minor changes.



Final allocation notifications:

- Provides States and LEAs with the allocations on which ED makes the July 1 awards and information about the allocation calculations
- SSA sends the final allocations to States once data are available to calculate these allocations
- Most years, differences between the preliminary and final allocations are generally due to updates to certain data elements in the formulas after ED issued the preliminary allocations (e.g., for Title II, Part A, updated Census State population estimates)




Revised allocation notification:

- Usually only for Title I, Part A (sometimes for Title II, Part A)
- Occurs primarily due to corrections by States to the State perpupil expenditure data after July 1
- SSA generally sends the revised final allocations to States in September and bases the October 1 Title I, Part A awards on the revised allocations

OFFICE OF SAFE AND SUPPORTIVE SCHOOLS (OSSS)



- As with Title I, to support States and LEAs in planning for school year 2022-2023, ED issued preliminary allocations to the Title IV-A State Coordinators in March 2022 with the final allocations sent in July 2022
- FY 2022 appropriation for Title IV-A: \$1.28 Billion
- Awarded July 1, 2022




Bipartisan Safer Communities Act

Under the School Improvement Programs section of the Bipartisan Safer Communities Act (BSCA), the Department will award grants to SEAs for the purpose of providing competitive grants to high-need LEAs for activities under section 4108 of the Elementary and Secondary Education Act of 1965 (Activities to support Safe and Healthy Students). Each SEA shall make awards on a competitive basis to high-need LEAs as determined by the State.

\$1 Billion available funding.
